Brittney Lynn Dorton JD Candidate, Class of 2025

Brittney "Britt" Dorton came to law school hoping to make justice accessible to all. Her own experiences as a disabled person and her prior work with incarcerated individuals taught her about inequities in the legal system and motivated her to pursue public interest law.

At Michigan Law, she spent two years as a studentattorney in the Michigan Innocence Clinic, served on the boards of the Sentence Commutation Project and the National Lawyers' Guild, and was a notes editor for the *Michigan Journal of Law Reform*. As the co-president of the Disability Rights Organization, Dorton has been an advocate for increased accessibility in the law both on campus and beyond.

After graduation, she will start her career in San Francisco as a Skadden Fellow with the national American Civil Liberties Union's Disability Rights Program. There, she will fight for the dignity of people with disabilities by challenging restrictive conservatorships in California.

Having graduated from the University of Chicago in 2020, Dorton is excited to finally experience an in-person graduation ceremony. She is endlessly grateful to those who have supported her through law school and to her classmates for trusting her with the opportunity to speak today.



David A. Breach, '94 President and Chief Operating Officer Vista Equity Partners

As Vista's president and chief operating officer, David A. Breach, '94, sits on Vista's executive committee—the firm's governing and decisionmaking body for matters affecting its overall management and strategic direction—as well as the firm's private equity management and

private equity funds' investment committees. Breach is the co-chief executive officer of VistaOne, Vista's evergreen private equity vehicle, and serves on its investment committee and board of directors. He also sits on the boards of Vista portfolio companies Jamf, Solera, and Stats Perform.

Breach was born in a suburb of Toronto but later moved to southeastern Michigan with his family, where he graduated from high school at age 16. Following graduation, he enrolled at Eastern Michigan University and pursued a bachelor of business administration degree with a concentration in sales and marketing, while working full-time as a sales representative. Breach subsequently attended law school, beginning at Detroit College of Law before transferring to Michigan Law, where he graduated *magna cum laude* and was a member of the Order of the Coif.

Following law school graduation, Breach was an associate at Honigman Miller, where he worked in corporate law. Before joining Vista Equity Partners in 2014 as its chief operating officer, Breach was a senior corporate partner at Kirkland & Ellis, representing private equity funds in all aspects of their business. While at Kirkland & Ellis, Breach was a member of its global executive management committee and was a founding partner of its San Francisco office.

The Headnotes



Profile of the Class of 2025





ONE OF THE MOST COLORFUL FEATURES of an academic procession is the appearance of the graduates and faculty in full academic attire. These caps, gowns, and hoods have long histories, and their patterns and colors have special significance.

The origins of academic dress date back to the 12th and 13th centuries, when universities were taking form. The ordinary dress of the scholar—student or teacher—was the dress of a cleric.

In modern universities, the distinctive mark of a degree is the hood, which in its earliest form was simply an article of clothing; since churches and lecture halls of European universities were cold and drafty, scholars wore their hoods as head coverings. American institutions, unlike those of England and Europe, have adopted a standard code of academic costume. The design of the gown; the color of the tassel on the cap; and the pattern, length, and colors of the hood all have special significance.


Both the associate and bachelor's gowns are closed at the throat and have long, pointed sleeves. The master's gown has oblong sleeves, open at the wrist, tapering at the back in a square cut, which ends in an arc cutaway. The doctor's gown is faced with velvet and has bell-shaped sleeves. Each sleeve carries three bars of velvet or chevrons.

The most colorful part of the costumes is the hood. The color of the velvet trim indicates the department that granted the degree, and the width of the trim corresponds to the level of degree (two, three, and four inches, respectively). The lining, or area inside the velvet, denotes the college or university awarding the degree. Michigan Law juris doctor candidates have purple velvet trim and maize and blue lining.

During the juris doctor degree recognition, recipients receive their hoods from faculty marshals as they enter the stage. After being draped with the hood, they walk across the stage for individual recognition.

1946 •	Publication of the casebook <i>CASES ON REMEDIES II: RESTITUTION</i> <i>AT LAW AND IN EQUITY</i> , by Professors John P. Dawson and Edgar N. Durfee, which marked the creation of restitution law.
1969 •	Publication of the influential casebook BASIC CRIMINAL PROCEDURE: CASES, COMMENTS AND QUESTIONS , by Professors Yale Kamisar and Jerold H. Israel (with Wayne R. LaFave).


